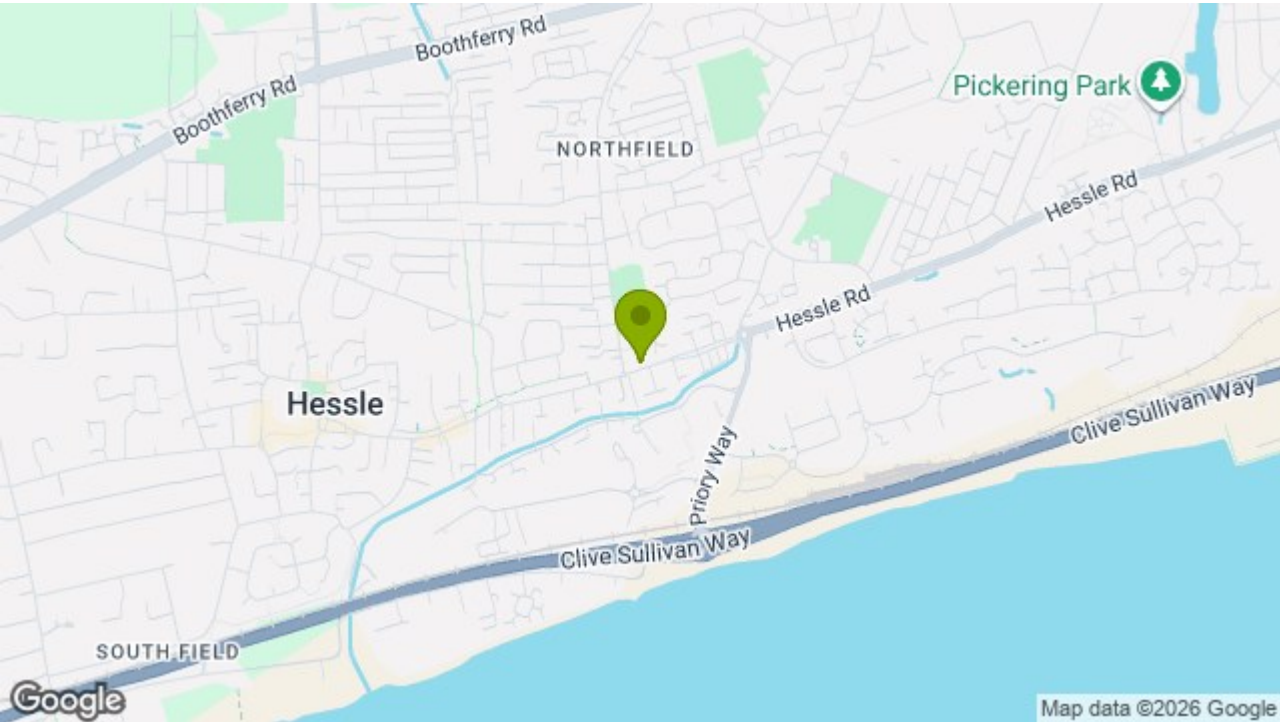

HESSLE

PORCH

Providing access to the accommodation.

KITCHEN

With white gloss wall and base units, laminated work surfaces and upstands. Integrated appliances include a Gas Hob, Smeg Electric Oven and an Extractor. Further benefitting from recessed spotlights, access to the Utility Room, a window and door to the side elevations.
