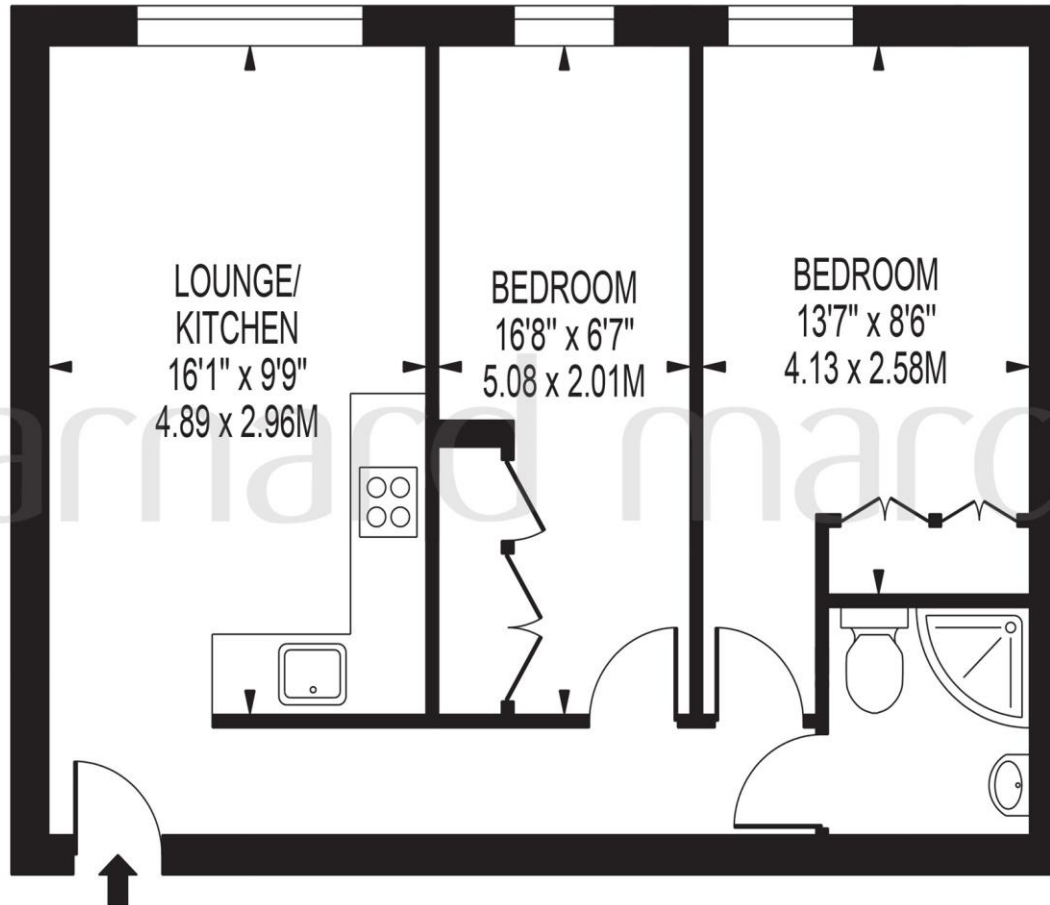
Further benefits include gas central heating, a secure entry phone system, and on-street parking.
