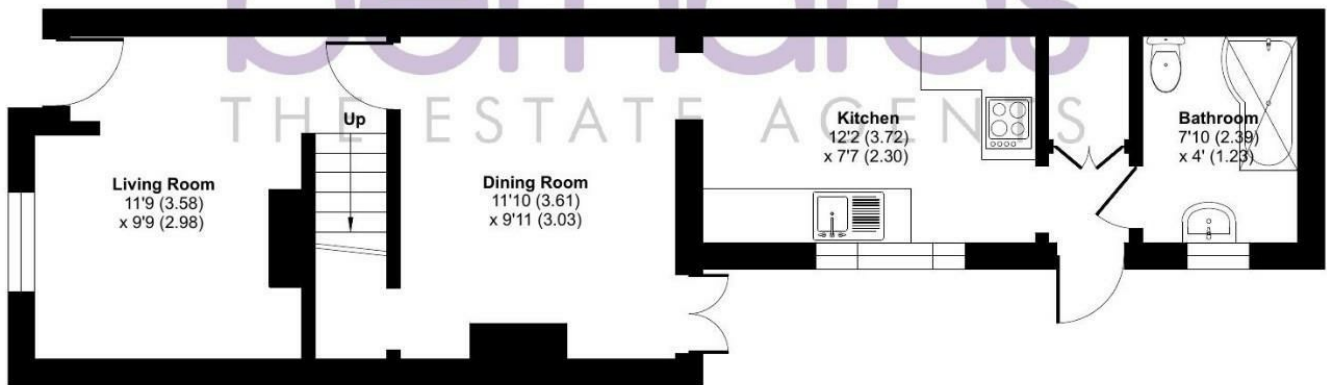

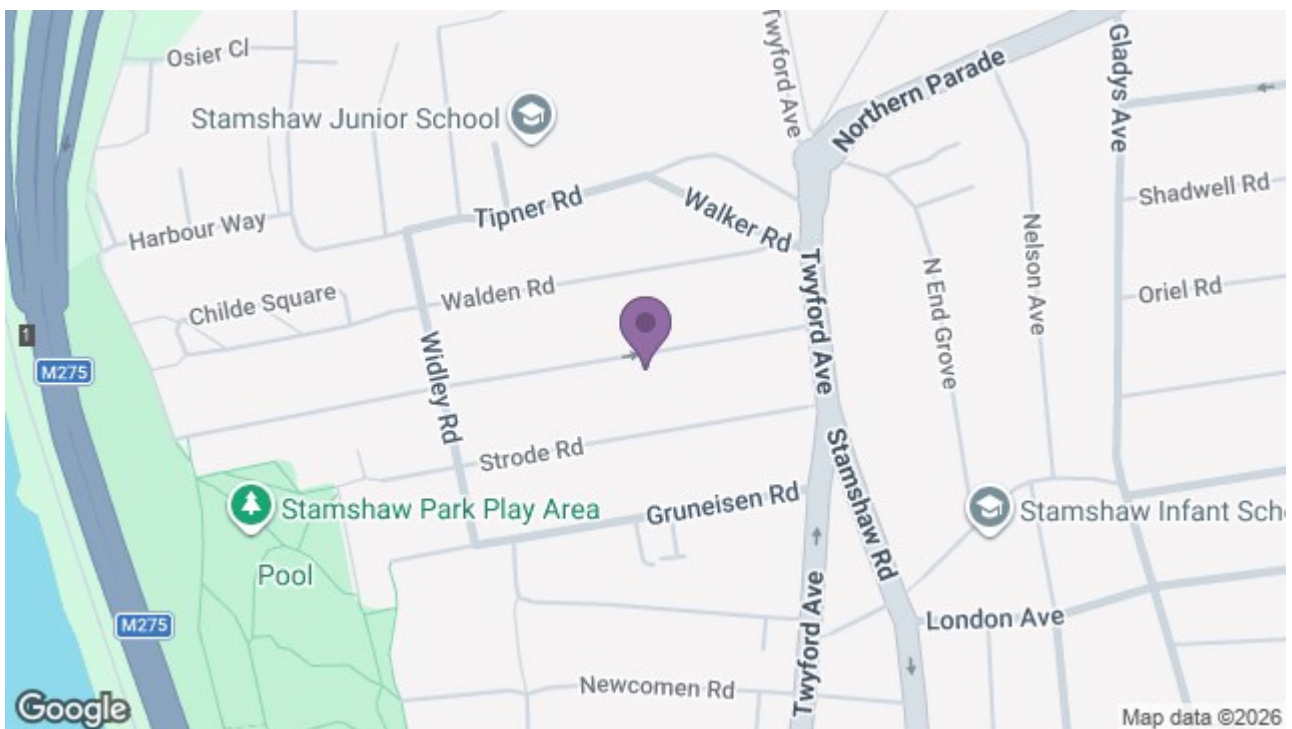


FIRST FLOOR
