There are highly regarded schools in Newport, all with excellent OFSTED ratings, including two selective secondary schools, along with a selection of independent shops, larger chain style shops and supermarkets, as well as a variety of leisure facilities. Regular bus services run from the centre of Newport to the larger towns of Telford (10 miles) and Stafford (16 miles) with their mainline train stations, wider range of shops and leisure facilities. Commuting to Chester, Shrewsbury, Wolverhampton or Birmingham would be possible as there is to easy access to the main road network from Newport.

Entrance Hall

Having radiator and large shelved storage cupboard.

Cloakroom / WC

Having a low-level flush WC and wash basin with cupboard. Side aspect double glazed window and radiator.

Lounge

Central brick feature fireplace and gas fire. Two radiators. Two front aspect double glazed windows.

Kitchen

Modern base and wall mounted units comprising cupboards and drawers with contrasting work surfaces above. Stainless steel sink with drainer and integrated oven with 4 ring gas hob above and extractor over. Space for undercounter fridge, freezer, washing machine and dishwasher. Rear aspect double glazed window and door to rear garden. Radiator.

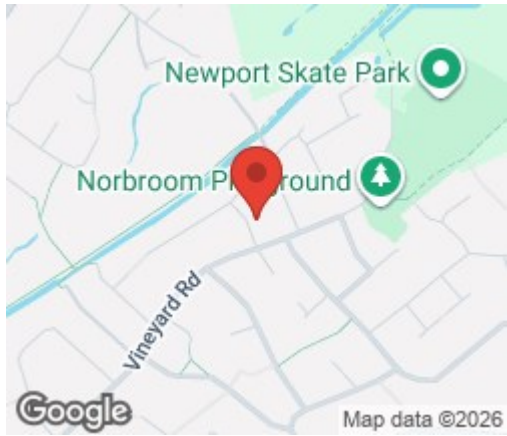

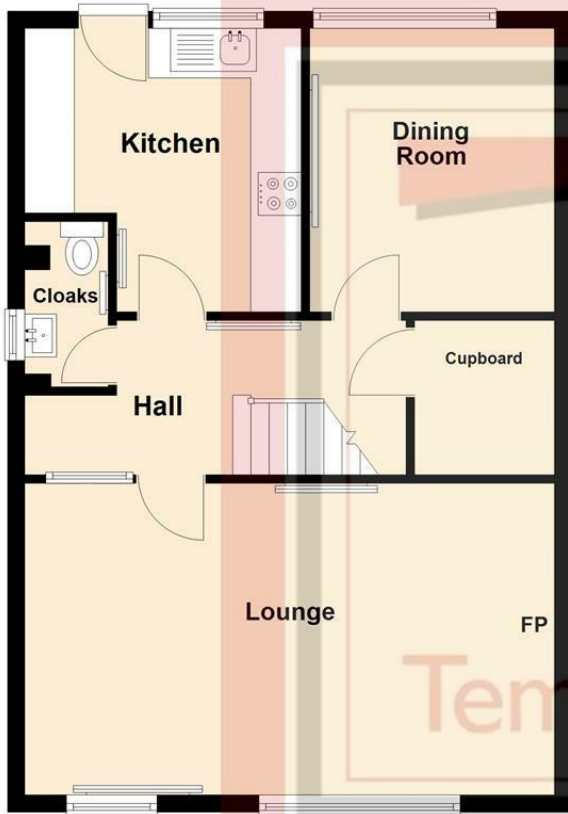

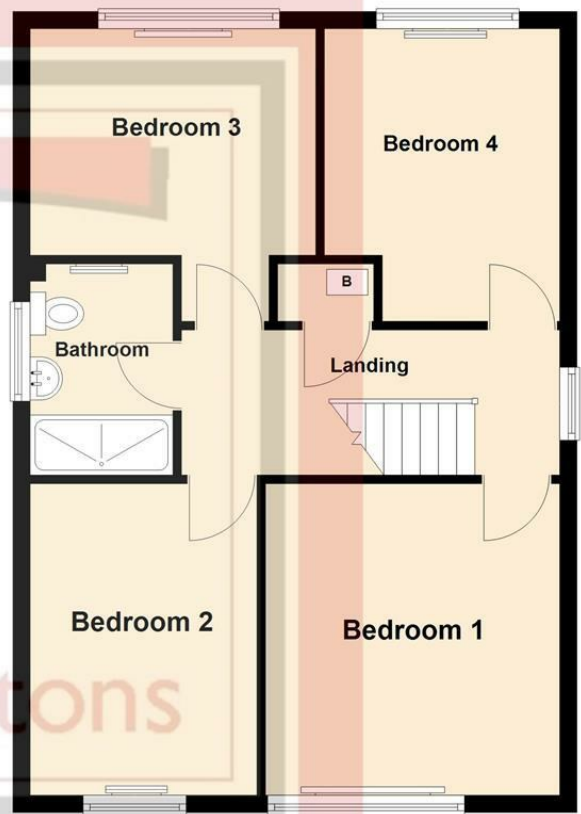
Ground Floor
