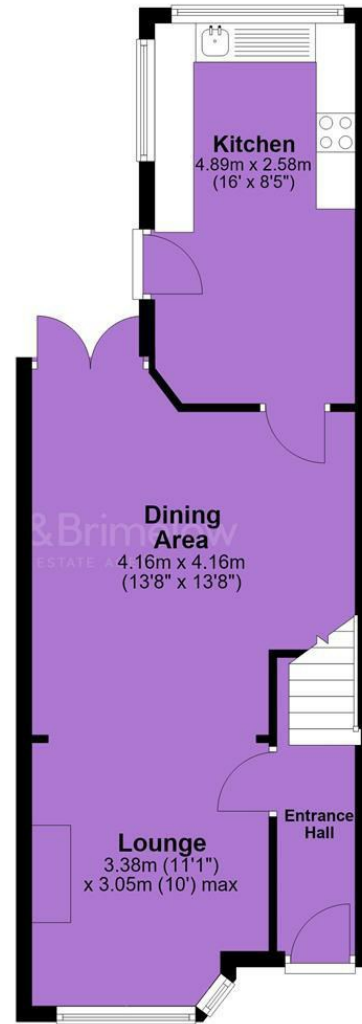


EPC Chart
