



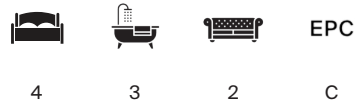

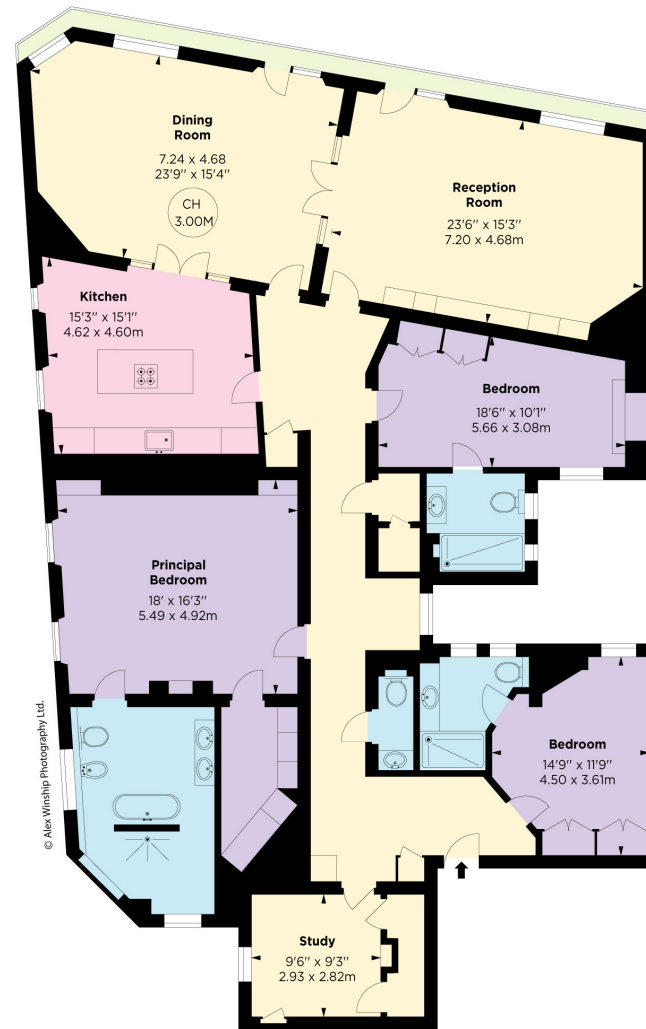
GRAND GARDEN SQUARES
