Entrance Hall

Enter via a solid timber door, electric panel radiator and airing cupboard housing hot water tank.

Lounge / Diner

17' 3" x 14' 6" max (5.26m x 4.42m max)

Double glazed sliding door with double glazed windows to either side leading to a balcony with sea view, carpet flooring and two electric panel radiators.

Kitchen

Floor and wall mounted kitchen units with work surface over, one and a half bowl sink and drainer unit with mixer tap over, electric oven and hob with stainless-steel cooker hood over and stainless-steel splash back, integrated dishwasher and integrated fridge-freezer.

Bedroom 1

15' 3" x 8' 10" (4.65m x 2.69m)

Double glazed floor to ceiling window to rear with water view, built out double wardrobe, electric panel radiator and door to ensuite.

WC with enclosed cistern and push button flush, wall mounted wash hand basin with mixer tap over, double width shower, fitted vanity mirror to one wall, ladder style radiator, spotlights, part tiled walls and tiled floor.

Bedroom 2

Double glazed door to balcony, double glazed floor to ceiling window to rear with water views and electric panel heater.

Bathroom

WC with enclosed cistern and push button flush, wall mounted wash hand basin with mixer tap over, panelled bath with shower and screen over, fitted vanity mirror to one wall, ladder style radiator, spotlights, part tiled walls and tiled floor.

Balcony


Sea views, laid to patio slab with glass balustrade
