Offered with no upward chain.

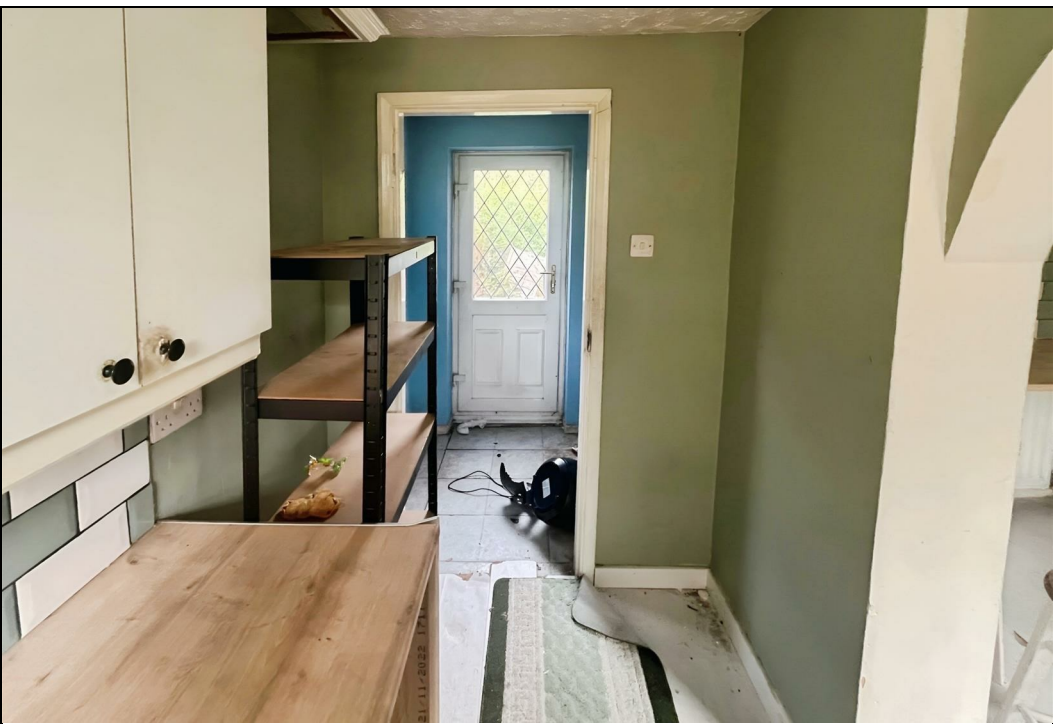
