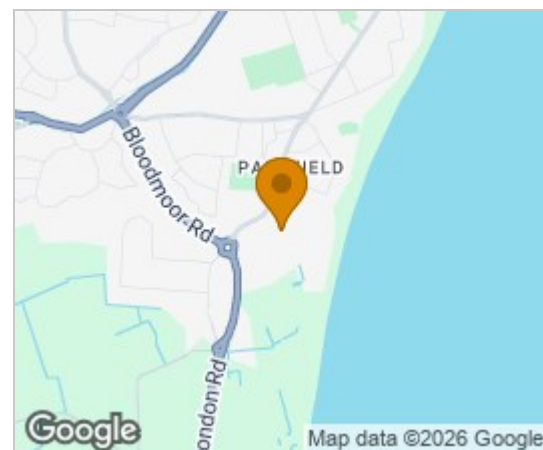

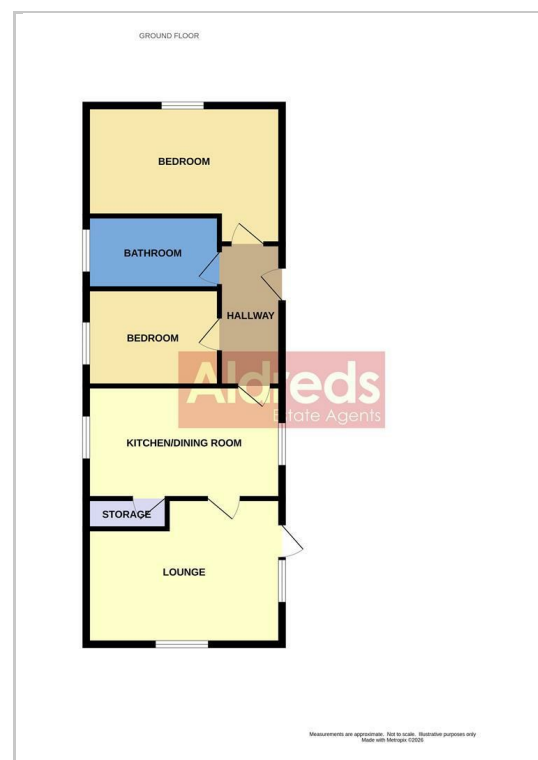

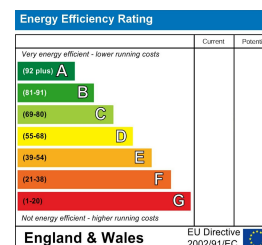
Area Map
