





## Property Description

Located within a well-regarded retirement development close to Bicester town centre, this ground-floor one-bedroom apartment is available with no onward chain and offers a comfortable, secure setting for independent living. The property benefits from 24-hour on-site care support, providing reassurance and flexibility for residents who may require assistance now or in the future.

The apartment features a spacious living/dining room with French doors opening outside, creating a bright and airy feel. The fitted kitchen includes an electric hob, oven, fridge freezer and washing machine. The double bedroom is generously sized and accompanied by an en-suite wet room designed for ease of access. Emergency pull cords and an intercom system are fitted throughout for peace of mind.

Residents have use of communal lounges and social spaces, with regular events and activities available for those wishing to take part. The development is ideally positioned within walking distance of the town's shops, cafés, restaurants and leisure amenities.

This shared ownership property is offered at a 75% share, with no rent payable on the remaining 25%. A range of care packages can be tailored to suit individual needs, with charges based on the level of support required. Monthly fees and lease details are listed below.
