This attractive two-bedroom penthouse retirement apartment is situated on the top floor of Minster Court, a luxury retirement development nestled off Bird Street in the city centre. Lichfield offers a range of amenities including boutique shops, cosy cafés, markets, pubs, and a vast array of restaurants. There are two railway stations providing services to Bromsgrove, Birmingham, London Euston and many more, and nearby road links include the A51, A38 and M6 Toll road.

The tastefully appointed accommodation has thermostatically controlled electric heating and comprises; L-shaped hallway, off which is a useful built-in cupboard with cloaks space and a further large double doored cupboard housing the hot water system. There is a spacious lounge with dining area, a really lovely room with two windows overlooking the courtyard garden, having carpeted flooring, two ceiling light points, feature electric fire and a door into the fitted kitchen, which has a range of matching base and wall cupboards, stainless steel sink and integrated appliances.

The master bedroom has built-in wardrobes and a window with views across Minster Pool towards Lichfield Cathedral. There is an en suite bathroom with a wash basin and adjacent cupboards, WC, chrome heated towel rail and panelled bath with mixer tap shower. Bedroom two is another double room, also having views towards Minster Pool and the Cathedral. The shower room has a tiled corner shower, WC chrome heated towel rail and wash basin with adjacent fitted cupboards. There is also a Creda wall mounted fan heater.

There is a part time house manager and a Care line instant alert call system.

Service Charge

Currently £500 per annum, includes Careline, buildings insurance, water charges, cleaning and maintenance of common areas.

Electrically controlled gateway access to the main entrance of Minster Court, there is a communal courtyard patio garden with seating areas, pergola and fountain.

Owners lounge on the first floor overlooking the courtyard, laundry room, communal storage room and guest's/visitors suite subject to availability.

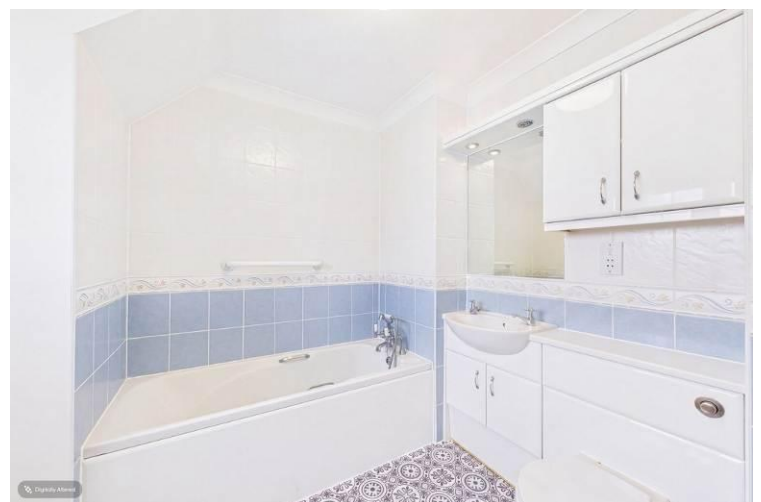
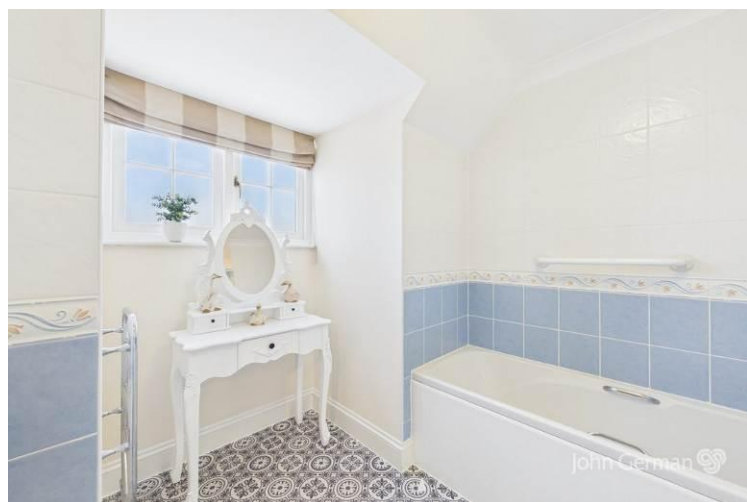
