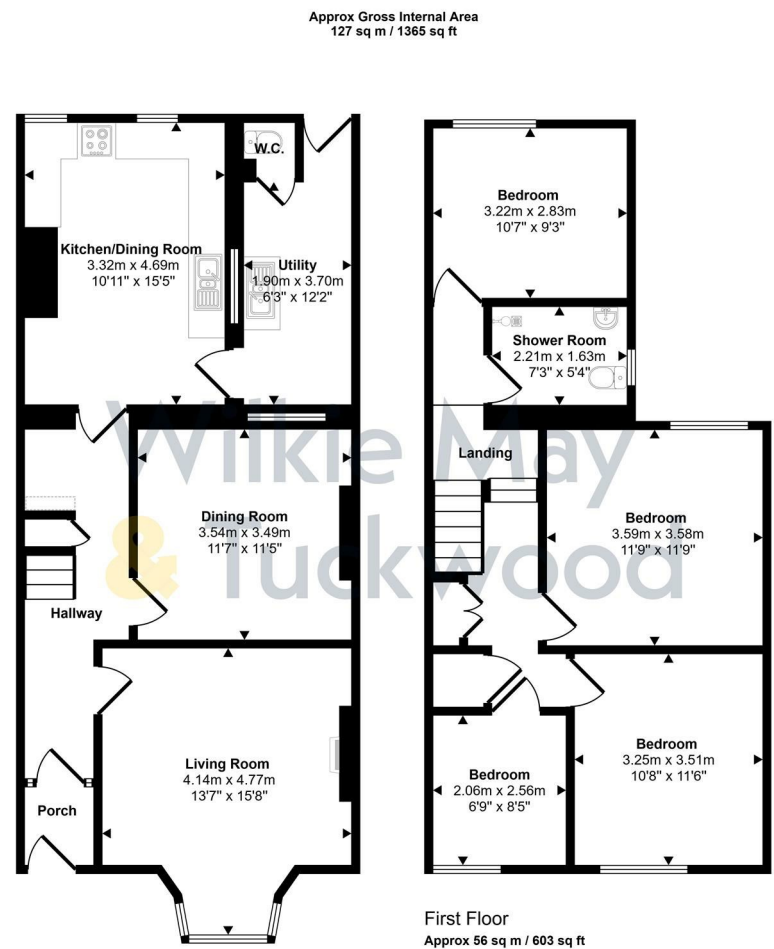

The accommodation in brief comprises; Upvc composite door into Entrance Porch; wood effect laminate flooring, glazed door into Entrance Hall; under stairs storage. Door into Living Room; aspect to front, bay window, feature fireplace, alcove shelving. Dining Room; with aspect to rear. Kitchen/Dining Room; with double aspect, modern fitted kitchen comprising a range of cream shaker style cupboards and drawers under a squared edge wood effect worktop with inset one and a half bowl stainless steel sink and drainer, mixer tap over, tiled splashbacks, space for dual fuel oven with extractor hood over, wall mounted Ideal combi boiler for central heating and hot water, space and plumbing for a dishwasher, space for tall fridge freezer, ample room for dining table, door into Utility Room; enamel sink with cupboard under, tiled floor, space and plumbing for a washing machine, door into Downstairs WC; low level WC. Composite stable door to rear lane.
