## DERRIFORD

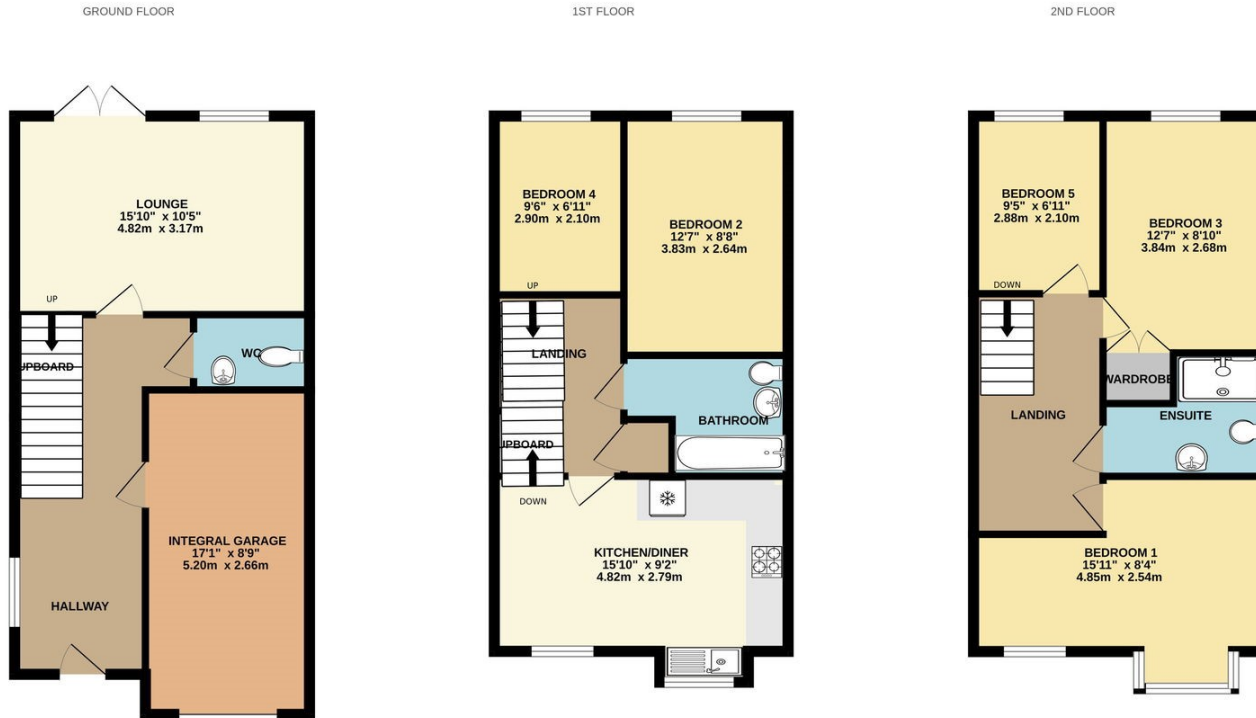
