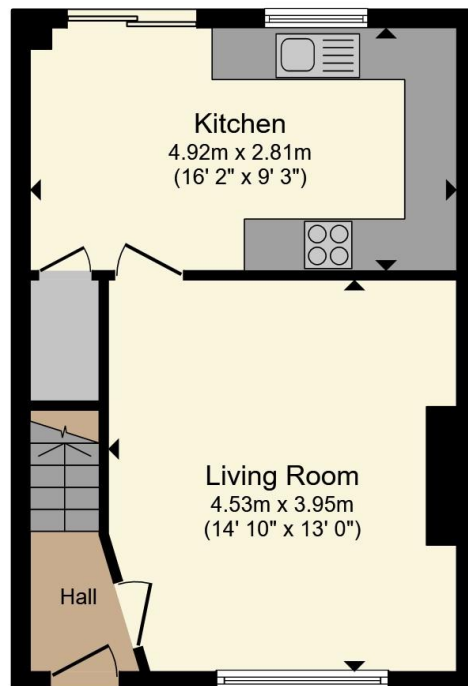

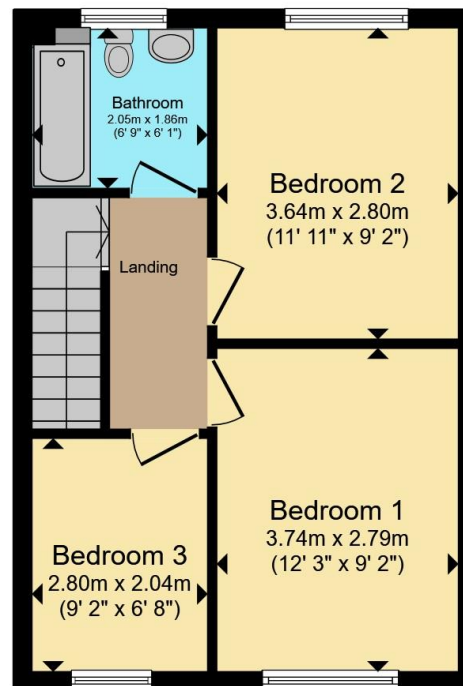








Ground Floor
