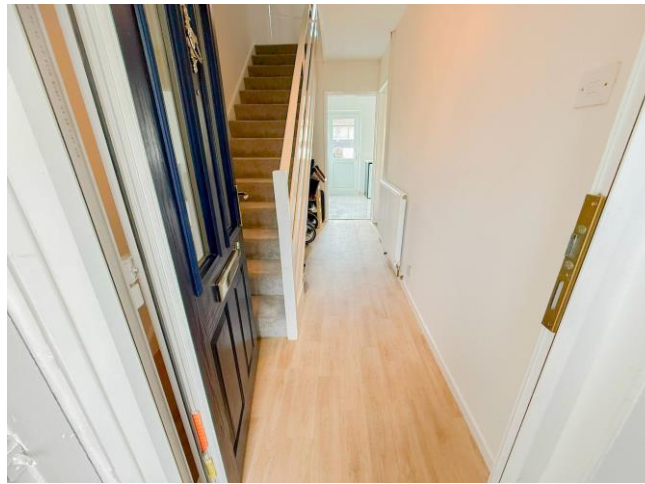
This conveniently located well presented modern style mid terrace property sits within close proximity of many amenities including local parks, shops, schools and transport links.
