### **Bedroom Two**

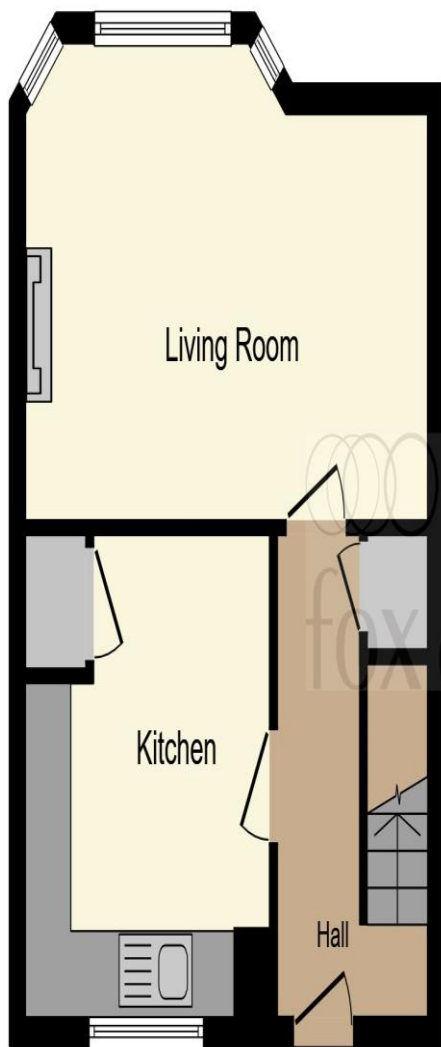
Double glazed to front elevation. Textured ceiling. Smooth walls. Radiator. Carpeted flooring.

### **Shower/Wet Room**

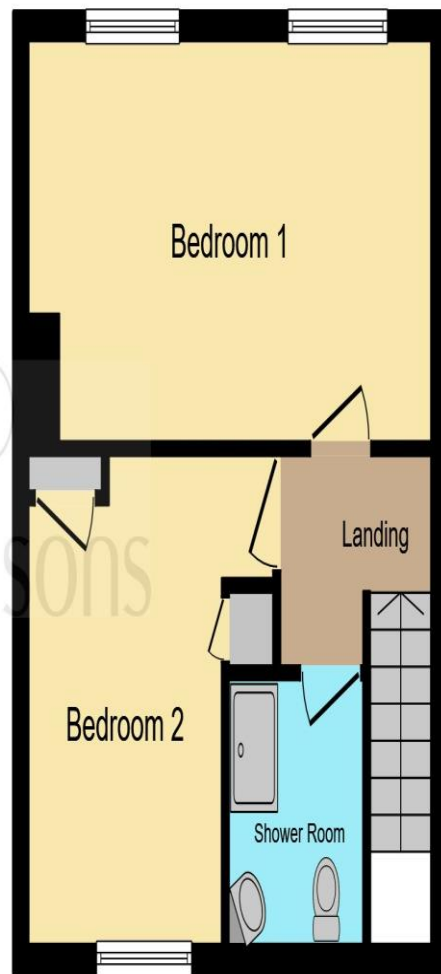
