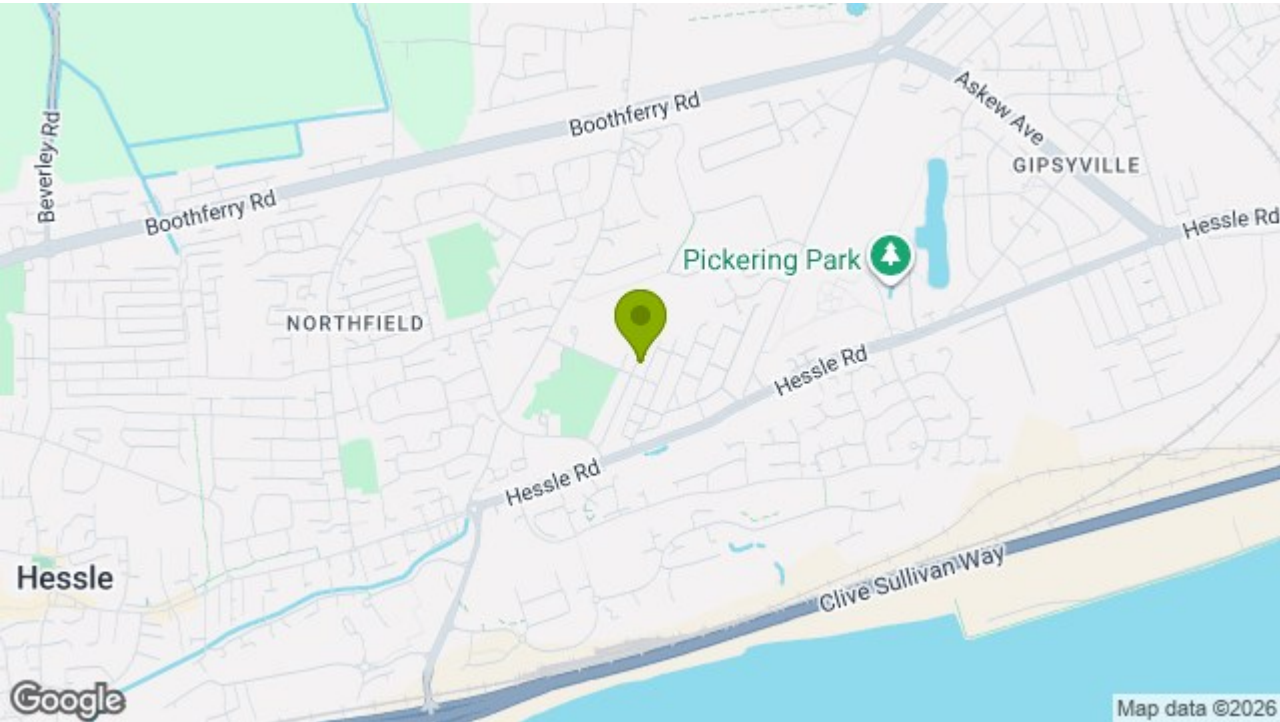

GROUND FLOOR;

ENTRANCE HALL

Providing access to the accommodation with stairs off.

LIVING ROOM

A generous living space with bay window to the front elevation and open to the sitting/dining area.

SITTING/ DINING AREA

A versatile reception space with bay window to the side elevation and access to the storage cupboard.

KITCHEN

A well equipped kitchen with a comprehensive range of wall and base units, contrasting laminated work surfaces and a tiled splashback. Integrated appliances include an Electric Hob, Electric Oven and an Extractor with plumbing provisions for a Washing Machine.

With low flush WC and a wash hand basin.
