Lounge

Front facing upvc double glazed window, radiator, laminate flooring and front door providing the property entrance. Period features include decorative coving. Access to the dining room and between there is a storage cupboard, providing practical storage between the two rooms.

Dining Room

Rear facing upvc double glazed window, radiator, laminate flooring and stairs that rise to the first floor landing. Access to the kitchen.

Kitchen

Fitted with base units, worktop and sink and drainer with tap. Space for a freestanding cooker with gas cooker point and plumbing for a washing machine. Rear facing upvc double glazed window with side facing door to the rear garden and radiator.

Front facing upvc double glazed window, storage cupboard and radiator.

Bedroom Two

Rear facing upvc double glazed window and radiator.

Bathroom

Three piece suite comprising of a panelled bath, pedestal wash hand basin and low-level WC. Rear facing upvc double glazed obscure window, radiator, extractor fan, tiling to the walls and storage area with wall mounted boiler.

Outside

To the rear is a spacious garden with fencing to the side a heightened brick rear wall garden with two outbuilding storage areas.
