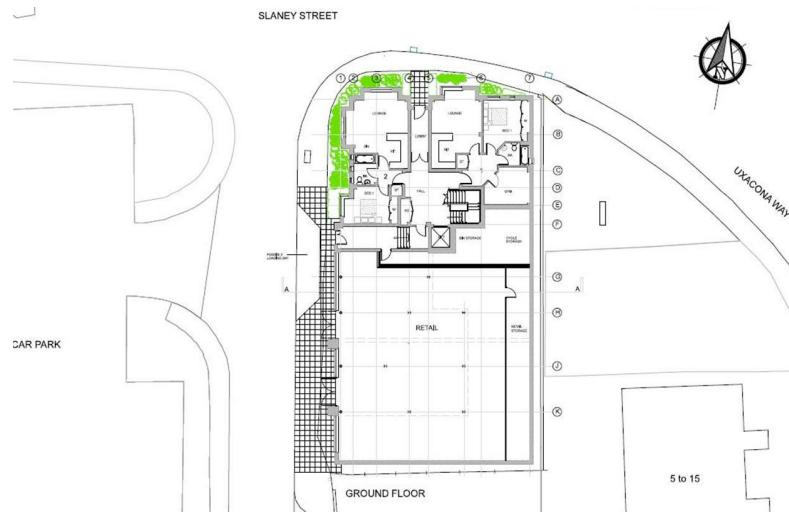

## Description

This site comprises of 2 x 2 bedroom semi-detached houses that sit on a parcel of land measuring 0.15 acre.

The land has full planning permission for "Demolition of existing 2no. dwellings and erection of 10no. apartments and 1no. retail unit".

## Location

The land & property is conveniently positioned within a well-established residential area of Telford, offering excellent access to local amenities and transport links. The property is within easy reach of a range of everyday amenities including local shops, supermarkets, schools and leisure facilities, with Telford Town Centre providing a wider selection of retail, dining and entertainment options just a short drive away. Road connectivity is strong, with the A442 and A5 nearby, providing direct routes to the M54 motorway and onward links to the M6, making the location ideal for commuters travelling across the Midlands. Rail services are easily accessible from Telford Central and Wellington stations, both offering regular services to Birmingham, Wolverhampton and Shrewsbury.

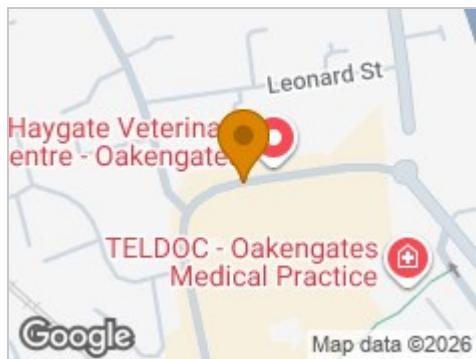
