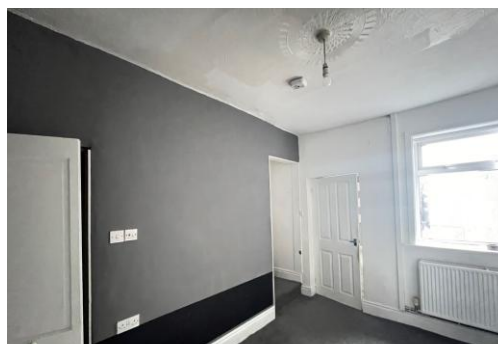

## PLEASE NOTE
