The Land

The 36.7 acre block of predominantly permanent pasture, is situated with excellent road access and conveniently sized enclosures. The land also has the benefit of a modern farm building being a three bay steel portal frame building with concrete panels to either side, cladding above and to the roof, hard core floor (13.4m x 10.4m approximately). A useful building for storage, livestock and other uses subject to necessary consents.
