First Floor Landing

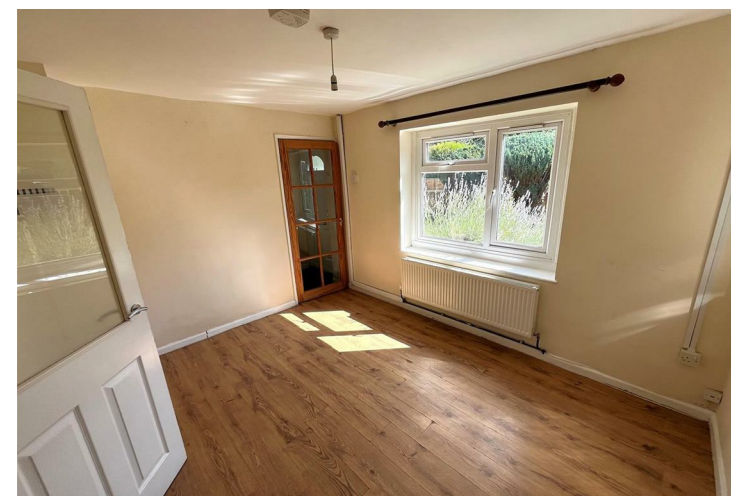
Window to rear aspect and doors leading off.

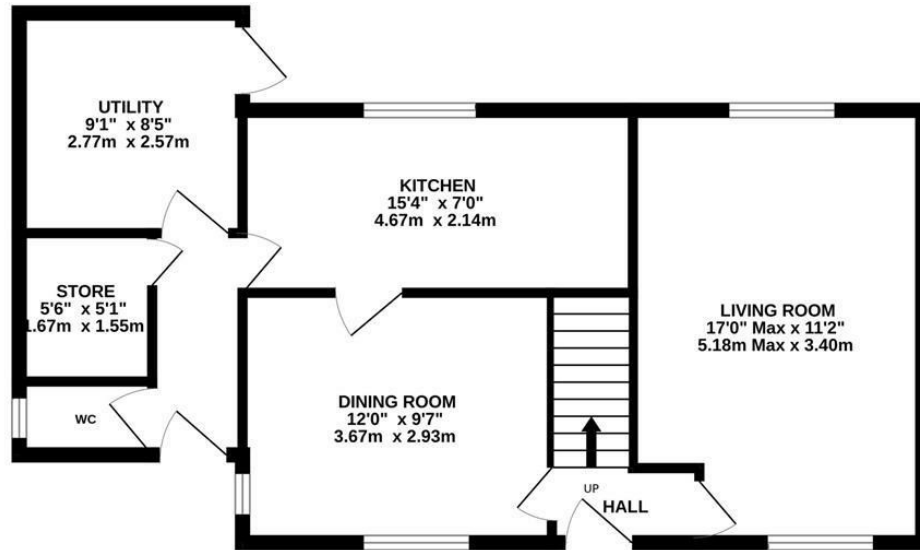

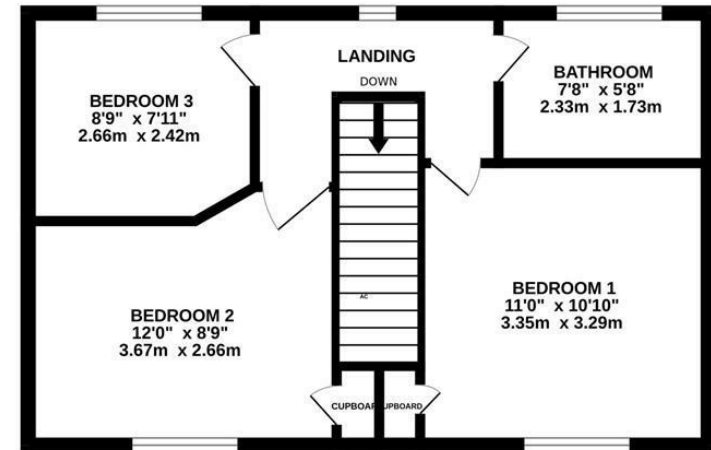




GROUND FLOOR
