The entrance hall leads to the lounge featuring a gas fire with a marble hearth, a double panel radiator and fitted carpet. The kitchen is fitted with a range of wall, base and drawer units, a convenient cupboard under the stairs, space for additional appliances, a Glowworm boiler, space for a table and a UPVC double glazed single doors leading to the rear garden.

The first-floor landing gives access to three bedrooms, all benefiting from radiators and fitted carpets. The fully tiled wet room comprises a Mira shower, a wall mounted wash hand basin, WC and a ladder style radiator.

Externally, the property benefits from private gardens to the front and rear, and a large wooden shed with light and electric.




