Offered to the market with no upward chain is this mature bay fronted two bedroomed mid terraced property featuring a refitted kitchen with built in appliances, refitted first floor bathroom, gas radiator central heating, uPVC double glazing and offers separate reception rooms and a rear garden measuring approx. 66ft in length. The accommodation briefly comprises porch, lounge, dining room, galley kitchen, two bedrooms, bathroom, front and rear gardens.
