**** Being sold via modern method of auction **** Set in a central sought after location, Hill Hook House is set back off the main Clarence Road and is within a short walking distance from local bus services and the cross city rail line. The property also has local shops and schooling set within close proximity. This spacious second floor two bedroom apartment benefits from pvc double glazing and electric storage heating (both where specified) and comprises of an entrance hall with large storage area off, fitted breakfast kitchen, spacious lounge, two bedrooms as well as a well appointed bathroom. Outside there are communal gardens, parking onsite. To fully appreciate the property on offer, we do highly recommend an internal inspection.

Set back from the roadway behind a lawned foregarden with shrubs, bushes and trees, a pathway gives access to the property via:-

COMMUNAL ENTRANCE HALL: Pvc double glazed obscure door and window, intercom/door release system, stairs leading off to all floors.

RECEPTION HALL: Multi lock wooden front door with useful storage cupboard, doors off to:

FITTED KITCHEN: 9'03"x 7'05" Pvc double glazed window to side, single stainless steel sink and drainer unit set in box edge work surfaces comprises a range of fitted units to both base and wall level, including drawers, tiled splashback, plumbing and recess for washer/dryer, integrated single oven with hob over and extractor canopy above, space for fridge freezer and tiled flooring throughout.

LIVING AREA: 12'6" x 11' Pvc double glazed window to side, electric coal effect fire with mantel piece surround, laminate flooring throughout.

LANDING: Wall hung electric storage heater with doors leading off to:

BEDROOM ONE: 13'09" max / 13'07" min x 11'2" Pvc double glazed window to side and rear, wall hung electric storage heater.

BEDROOM TWO: 11'07" x 6'9" Pvc double glazed window to rear and wall hung electric storage heater.


BATHROOM: 7'8" x 5'9" Pvc double glazed obscure window to side, comprising matching suite, bath with shower over, low level WC, wall hung wash basin, tiles to wall and floor, airing/storage cupboard.

OUTSIDE: To the rear elevation there is a lawned garden and communal parking.

This property is for sale by the Modern Method of Auction. Should you view, offer or bid on the property, your information will be shared with the Auctioneer, iamsold Limited. 
