

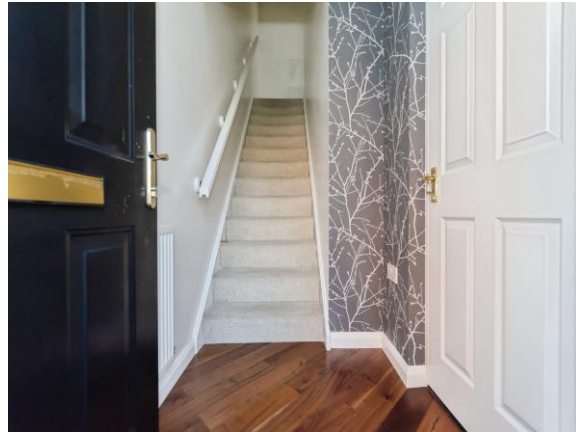


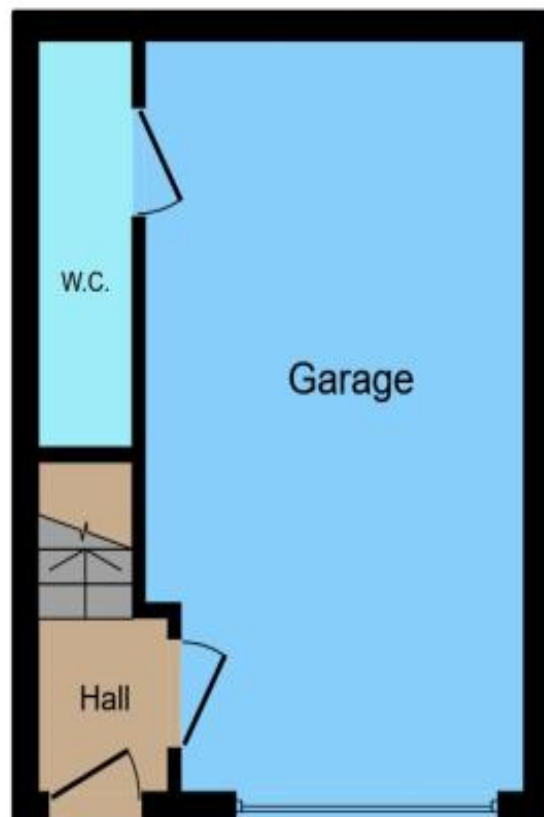

Via a footpath leading up to front door accommodation.

Entrance Hallway

Doors to garage and access up the stairs to first floor accommodation. Feature flooring.

Wc

Close coupled toilet. Central heating radiator. Sink and pedestal.

Lounge

17' 7" x 13' 1" (5.36m x 3.99m)

Double Glazed Window to front. Central heating radiator. Archway to kitchen. Door to inner hallway.

Kitchen

6' 7" max x 7' 10" max (2.01m max x 2.39m max)

Double Glazed window to front. Fitted Wall and base units with roll top work surface over. Stainless steel sink, drainer and mixer tap over. Tiling to splash prone areas. Integrated oven, hob and extractor hood. Space for fridge freezer. Feature flooring.
