Your solicitor will also agree with the seller what items (e.g. carpets, curtains etc) will be included in the sale.

Situated within walking distance to the railway station is this vacant three bedroom bay fronted terrace which benefits from uPVC double glazed doors and windows, built in kitchen appliances and gas radiator central heating. The property further offers a downstairs bathroom aswell as an upstairs shower room and a cellar. This ideally would suit a first time buyer or an investor. The accommodation briefly comprises entrance hall, dining room, lounge, kitchen, bathroom, three bedrooms, shower room and gardens to front and rear.
