A NOTABLE FEATURE IS THE ELEGANT CENTRAL CORRIDOR, REFLECTING ITS VICTORIAN CHARACTER WITH FLUTED COLUMNS, ORIGINAL MOULDINGS AND DECORATIVE BAS-RELIEF DETAILING.

The two principal reception rooms are positioned along the front of the apartment and are flooded with natural light through striking arched Victorian windows, enjoying open London rooftop views and an outlook towards Earl's Court Square Gardens. The kitchen is well positioned within the apartment and thoughtfully arranged, offering a practical and functional layout with good storage and workspace, well suited to both everyday use and entertaining. The apartment comprises three generous double bedrooms, including a substantial principal suite featuring a large en-suite bathroom, wardrobe/dressing room, small utility/laundry room and access to a private, not-overlooked south-facing balcony. A second bathroom and separate guest WC serve the remaining bedrooms. An additional benefit is the potential access to the private communal gardens of Earl's Court Square.
