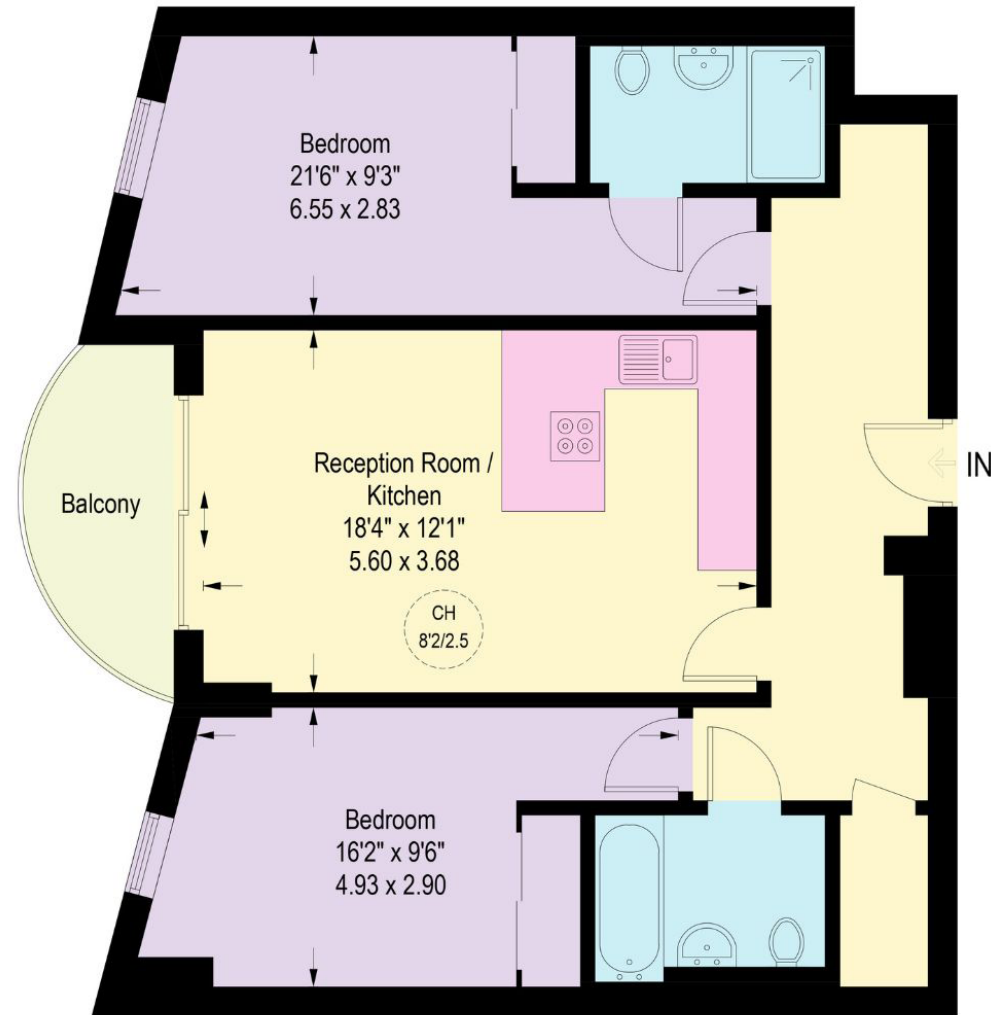
LATERAL APARTMENT NEXT TO THE RIVER THAMES
