



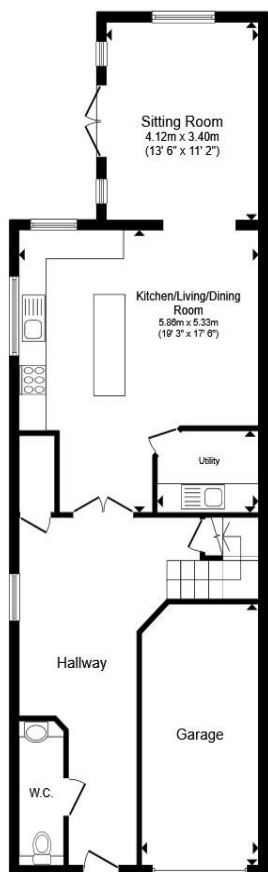

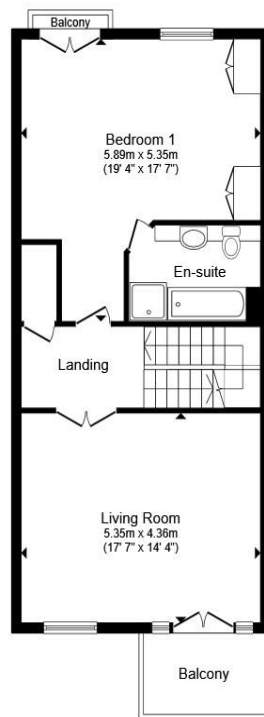

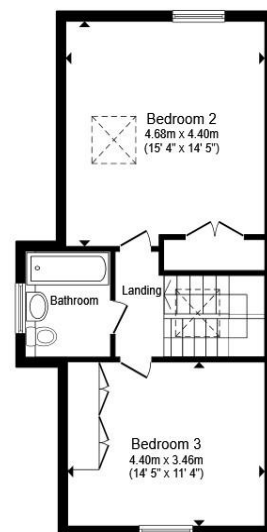




Ground Floor
