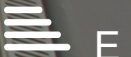

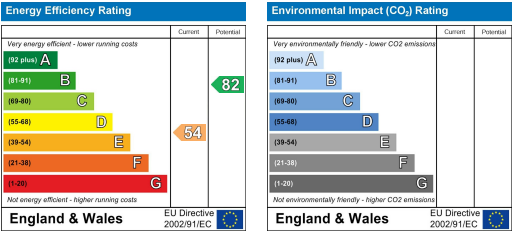
Floor Plan
