Offered for sale with on ongoing chain, this second (top) floor flat has gas central heating and double glazing and could suit a variety of different buyers from homeowners to investors. Once inside, an entrance hallway leads to an open plan kitchen/sitting room featuring a kitchen with a range of built-in appliances and a Juliette balcony.

There are two double bedrooms both with fitted wardrobes and the main bedroom has an en-suite shower room. The main bathroom is next to the second bedroom.

A private, single parking space belongs to the property and is numbered 30. There is a communal bike store together with a bin and recycling area.

Anstis Court is a popular development occupying a level position in the Woolbrook area of Sidmouth, just a short walk from a good range of day to day amenities to include a convenience store and tea rooms, Lidl supermarket and bus services to the surrounding area. Popular schools are close by along with Sidmouth College, and the town centre and seafront are around a mile and a half away.





Sidmouth is a popular and unspoilt town on the Jurassic Coast with a delightful, Regency esplanade. Amenities include Waitrose, Lidl, a cinema, theatre and busy High Street with numerous independent shops and restaurants.

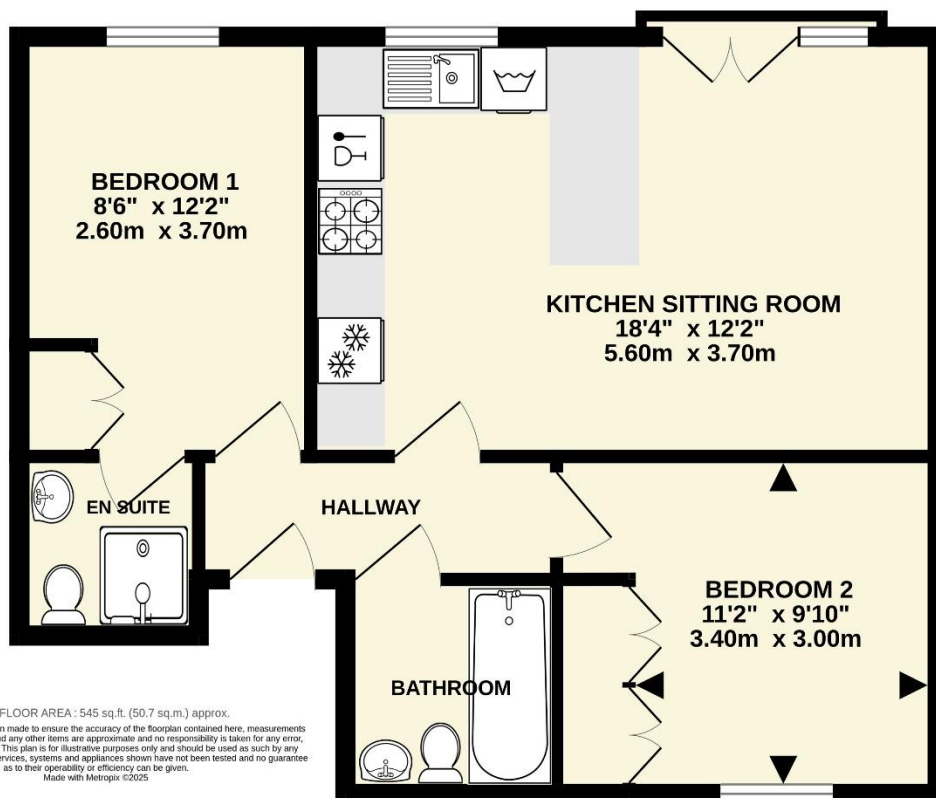
