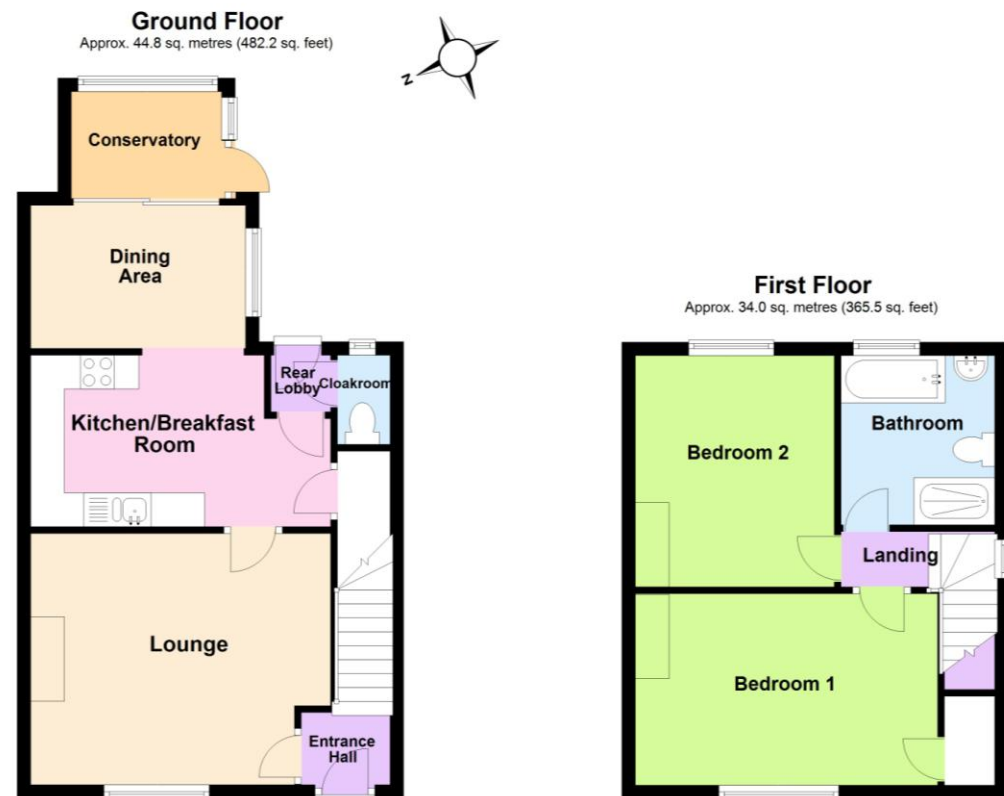

Situated on the northern outskirts of Irthlingborough is this mature two bedroomed end of terraced property featuring a single storey extension and conservatory to the rear and rear vehicular access providing gated off road parking for three cars. Benefits include uPVC double glazing, gas radiator central heating, modern kitchen with built in appliances, modern bathroom and offers two double bedrooms and no upward chain. The accommodation briefly comprises entrance hall, lounge, kitchen/dining room, conservatory, cloakroom, landing, two bedrooms, bathroom, front and rear gardens and a driveway.

Front - Mainly lawn with borders stocked with flowers and shrubs, enclosed by privet hedge and wooden panelled fencing.

Rear - Main lawn with border stocked with flowers and shrubs, greenhouse, large wooden shed, gated side pedestrian access, garden is enclosed by wooden panelled fencing. Driveway via wooden double gates through to blocked paved driveway providing off-road parking for up to 3 cars.
