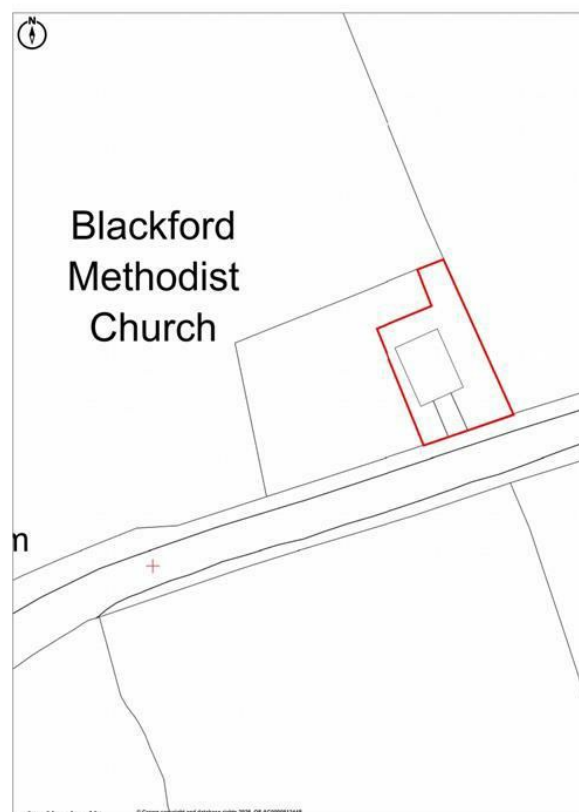

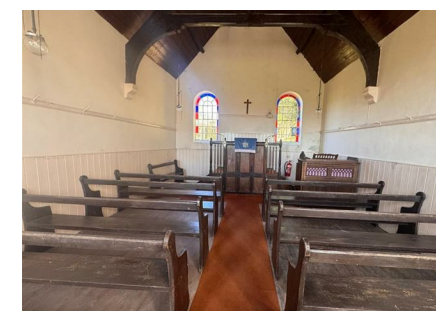

Blackford Methodist Chapel occupies a peaceful rural position on Thorn Lane within the parish of Stoke St Milborough, set amidst attractive south Shropshire countryside. 11.5 miles from Bridgnorth and 8.8 miles from Ludlow, the chapel is located just off the B4364, on Thorn Lane.

#### THE PROPERTY

Blackford Methodist Chapel is a picturesque Grade II Listed primitive Methodist Church which is believed to date back to 1869.

It retains numerous original features including attractive arched stained glass windows, timber panelling, Calor gas lights, timber pulpit and pews.

The chapel extends to 5.23m x 7.67m, with an external entrance porch.
