



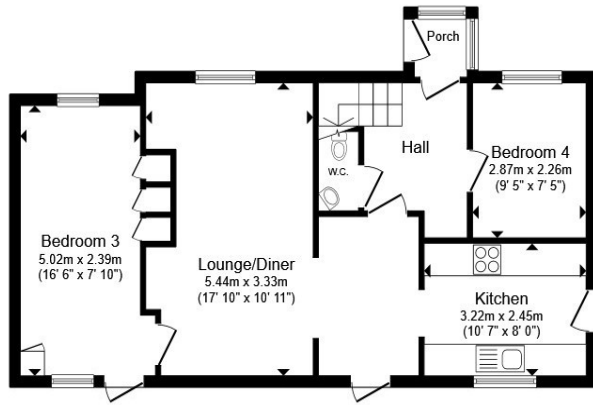

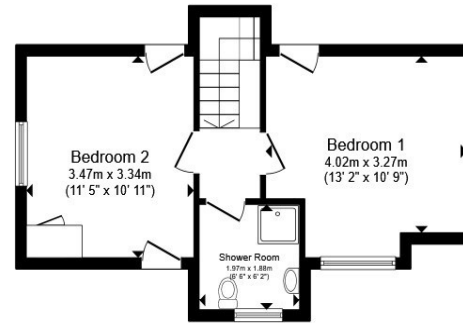

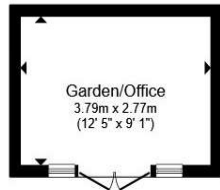




Ground Floor
