This beautifully presented three-bedroom semi-detached home on Oakdene Grove, Newcastle (ST5 8HD) has been thoughtfully extended and fully transformed to a high standard, offering stylish and versatile living throughout.

Upon entering, you are welcomed by a spacious entrance hall. To the right, the open-plan living and dining area features a media wall, a bay window to the front, and a rear extension with a further bay and French doors leading out to the garden, creating a bright and sociable space.

To the rear of the hallway is a modern kitchen with ample storage and integrated appliances including a gas hob, electric oven and fridge freezer. There is also understairs storage, currently used as a cloakroom with potential to convert into a pantry. The kitchen leads to the rear porch, which provides access to the garden, the front driveway and the garage conversion.

The converted garage includes a utility area, WC and additional storage. With a window overlooking the garden, this versatile space could be used as a fourth bedroom, home office or gym.

Upstairs offers three bedrooms, including two good-sized doubles, one with built-in wardrobes, and a third single bedroom ideal as a nursery or office. The family bathroom completes the floor. The loft is fully



boarded, providing additional storage space. A newly installed staircase with glass paneling leads to the first floor.

Externally, the property boasts a landscaped rear garden with artificial lawn, patio areas and a pathway leading to a stunning outbuilding, fully fitted as a bar and entertaining space. To the front, a driveway provides off-road parking for up to four vehicles. This home has been carefully updated throughout and offers a fantastic finish. Early viewing is highly recommended.

Floorplans


