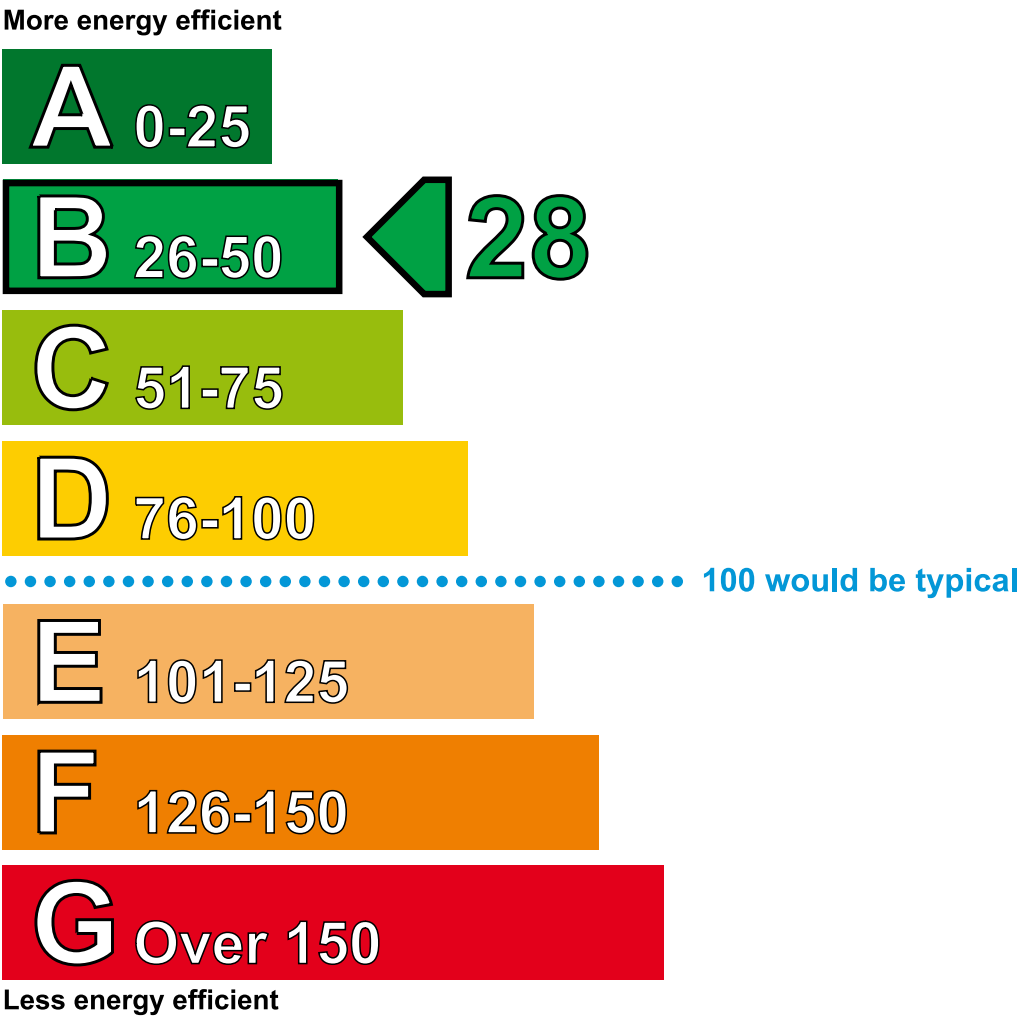

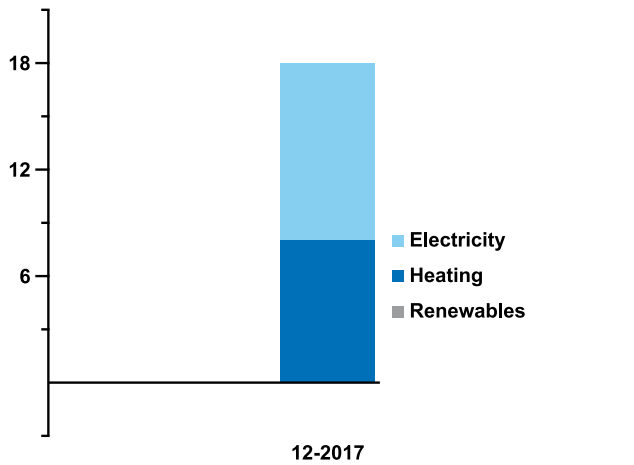
Energy Performance Operational Rating

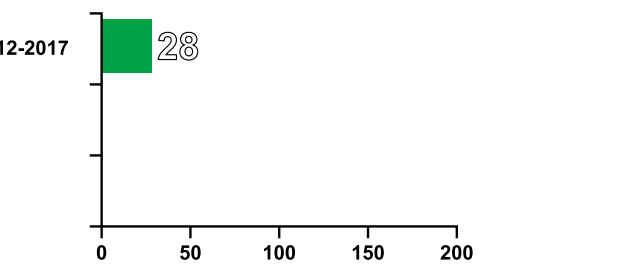
Total CO<sub>2</sub> Emissions
